



# Winchester Canyon Gun Club Private Range Use Agreement

In consideration of agreements contained herein, the parties agree as follows:

This agreement shall begin on \_\_\_\_\_, 20\_\_\_\_ and shall continue one year until \_\_\_\_\_, 20\_\_\_\_ unless terminated in writing by either party, for any reason, with 30 days prior notice. User agrees to pay WCGC \$\_\_\_\_\_ per client/guest/student and \$\_\_\_\_\_ for rental of a single field at the range for each day

1. During the term of this agreement User shall be allowed to perform the following: \_\_\_\_\_
2. It is mandatory that the User and all clients/visitors/students/guests must sign the WCGC waiver and release form before any operations may commence.
3. The User shall supply all necessary equipment, materials and supplies including but not limited to Targets, Guns, and Ammunition (unless rented independently) and shall not rely on the equipment of WCGC for completion of the services to be performed in this Agreement. WCGC retains the right to inspect, stop, or alter the services of the User to assure its conformity with any Range Rules and/or Club Safety regulations.
4. Any Firearm Range Instructors must be approved by the Range Manager. Any Firearm Instructor must provide a current approved Certification for Firearms Instruction.
5. User shall maintain General Liability Insurance with minimum limits of \$1M per Occurrence and \$2M in the aggregate in addition firearm instructors must also include Professional Liability. Certificate shall be received by the WCGC from the Users insurance agent before any activities can be performed. Certificate will name WCGC as an Additional Insured and waive any rights to subrogation. User shall also comply with any, and all, other insurances and/or benefits and/or tax issues as required by any local, State, or Federal jurisdiction which are necessary for their operations.
6. WCGC will not be responsible for any damage to, or loss of, any of the Users property or property of the Users guests/clients located at the Range regardless of the cause.
7. The User agrees to Indemnify and Hold Harmless the WCGC from any, and all, claims which may arise during the course of his or her activities. The User waives any claims for unemployment benefits and/or Workers Compensation benefits.
8. User and their clients/guests/students/visitors agree to follow all current WCGC rules, regulations and policies.
9. User agrees to keep the Range in the same or better condition after each use including cleaning the range and repairing any damage caused by User within 30 days or user will forfeit their right to use the facilities.
10. Any ammunition that is purchased from WCGC, arrangements must be made with the range manager prior to the event.
11. User has\_\_\_\_day(s) after date of use to pay all range fees to WCGC. If fees are not paid within 30 days, this can result in suspension or termination of User ability to use the range.
12. This Agreement shall be governed by the laws of the State of California. Jurisdiction and venue for all purposes shall be in the County of Santa Barbara, State of California.
